STAFF AND COMMITTEE REPORTS:

1. Project Updates

- i. Leah Clark updated that the Hayhurst Brothers have finished demo and started framing at 1305 10th Street. All of the permits have been submitted as well as an application for variance to the Zoning Board of Adjustments for the masonry requirement to be waved because all of the building renderings showed cedar.
- ii. Leah Clark updated that the Main Street Economic Restructuring Committee is presenting an idea to use wraps on windows downtown to show that the building is vacant and have contact information for Bridgeport EDC.
- iii. Leah Clark updated that Project Backpack is still on hold. Two different contractors are interested in build-to-suit.
- iv. Leah Clark updated that the downtown farmer's market is on hold. Main Street Director and EDC Director will follow up with the Community Market in May.
- v. Leah Clark updated that NCTCog now has an Economic Development District. This allows us to apply for grants that we have not been eligible for in the past.

- 3. David Correll made a motion to approve up to \$5000.00 for electrical infrastructure upgrades at Bridgeport Country Club. Second by Angie Tyson. Motion carries 3-0. Jonathan Fippinger abstains.
