# ANNOUNCEMENTS AND SPECIAL PRESENTATIONS:

Fred Meyers announced that he would be retiring from Meyers-McComis Agency at the end of the month.

## STAFF AND COMMITTEE REPORTS:

- 1. Project Updates
  - a. Sales Tax up 15% Fiscal YTD over 2019, Up 12% over budget projection
  - b. 707 Halsell Purchase waiting on Linebarger to reschedule the sale
  - c. J&M Materials Contract for land purchase has been terminated. They are looking for different financing options.
  - d. Ace Hardware BEDC has not had an update from them
  - e. COVID-19 Update As people are out in public more, positive cases are increasing a bit. BEDC is sanitizing the office daily and keeping groups as small as possible.
  - f. Wise Recovers Since Bridgeport City Council voted to partner with Wise County for the relief program, we will now have a local grant for eligible businesses. Businesses are eligible if they are located within Wise County. However, if the business resides within a city limits that chose not to participate then they will not be eligible. Eligible businesses had to have been partially or fully closed due to government order and are currently open or intend to reopen. There is \$769,824 available for grants. Each grant will be \$3,000 and awarded on a first come first served basis. Applications can be submitted at 8 AM on Monday, June 29th and will be accepted through July 5th.
  - g. TWC Helpline An additional Bridgeport citizen asked for assistance this week.
  - h. Project Coffee Bean Blessed Bru has made advance payments on loan through August.
  - i. Retail Strategies Study is still on hold until things pick up.
  - j. HTP Lease BEDC is interested in extending lease to HTP at Endeavor property (\$2,500/month). Expansion is currently on hold due to the recent oil and gas downturn.
  - k. Project Augustus Gloop A new project request was sent by the governor's office to be submitted by June 26th at 10 AM. The project is highly confidential. It is a food processing plant. They are looking for a minimum of 40 acres and natural gas. Close proximity to major highways and major dairy production (within 200 miles). They are sensitive to rail and are not looking for anything pre-existing. This would bring a \$40 million investment and 135 jobs. BEDC will be presenting Endeavor as a Greenfield site with established water, sewer, and electric. Winning a project like this would lend itself to a capital fund grant or possibly a bond to do infrastructure and gas expansion within Endeavor Industrial Park.
