STAFF AND COMMITTEE REPORTS:

- 1. Project Updates
 - a. Sales Tax Net payment to City was \$228,362.07. EDC portion was \$76,120.69. That is up 11% Fiscal YTD and 12.9% over 2020 budget projection.
 - b. 707 Halsell Purchase waiting on Linebarger to reschedule the sale
 - c. J&M Materials -There is a new contract on property set to close on Sept 28th
 - d. Ace Hardware Working on getting new financing
 - e. Project Flex BEDC is working to get appropriate paperwork to finish EDPA.

- f. HGTV and Hayhurst BEDC is working on an agreement with the production company to stage the house at Endeavor.
- g. Project Coffee Bean Blessed Bru has made advance payments on loan through August.
- h. Retail Strategies They will be using numbers for 2019 and Executive Director and Assistant will be doing Retail Academy training online instead of traveling to Alabama.
- i. Project Defense Using our address for State Department
- j. Marketing Lauren Stowers has been working on videos with Chamber to spotlight local businesses, created advertising for BEDC, as well as a suite of documents.
- k. Endeavor Adventure Park Parks Department would like to develop a couple more areas for non motorized use with grant money.
- I. Project Z No updates
- m. NRS Feed Store Leased a building on Hwy 380. They will carry feed, hay, and livestock necessities. They are interested in a Beautification grant.
- n. Drive In Circus Chamber is hosting a circus at Endeavor. BEDC is doing a \$1,000 sponsorship.
- o. Endeavor Road and Infrastructure Expansion Due to COVID, more EDA Funds are available. BEDC could possibly get 80% funding up to \$ 5M.

- 2) Offer \$15,000 for a 70' road and utility easement.

Jonathan Fippinger made a motion to request a first right of refusal to Jerry Franks for his property, Aurora Terra in Bridgeport, Texas with an option fee of \$500. David Correll seconded.

Motion carried unanimously.
