- 1. Project Updates
  - a. Board Member Updates Recommendation of appointment for Alan Green to the BEDC Board of Directors will be presented to City Council at their next meeting.
    - An overview of how Type A Sales Tax Revenue can be used was presented by the executive director.
  - b. Sales Tax Deposit was down 2.5% year over year this month.
  - c. COVID Updates There are currently zero COVID patients in Wise Regional hospital and 43 positive cases in Wise County.
  - d. Buildings and Grounds Landscaping projects will start in March.
  - e. Endeavor BEDC executive director is waiting to hear back from EMSI for a quote on a target market analysis.

- f. Endeavor Land Release 15 Acres has been released from the lender, making 45 acres free and clear. The executive director will start the 2021 request soon for an additional 15 acres.
- g. Endeavor Wall Materials should arrive tomorrow.
- h. Ace Hardware No new updates
- i. Project Coffee Bean The company continues to be delinquent on loan.
- j. Project Defense Company is working on a lease for Bob Carpenter's building on Hovey Street.
- k. Project Spire Company will present to the BEDC Board at next month's meeting. They are looking to lease a building on Lake Road to relocate their bottling facility from Lewisville.
- I. Marketing BEDC is pushing storm and COVID relief on social media. There is new COVID relief available, as well as new SBA loans for storm relief. BEDC staff will learn more about storm relief in an upcoming webinar. Updates are being made to EDC and Destination Bridgeport websites by ThinkMents. They are also looking at additional tools to add to the websites for small businesses to utilize.
- m. Main Street Executive director is looking into renovation reimbursement opportunities with the Texas Historical Commission for properties that may be eligible for a historical marker, have a historical marker, or are in a historic district.
- n. Destination Bridgeport BEDC has been partnering with Main Street on advertising for Destination Bridgeport.
- o. Carillon Park The property is still under contract.
- p. Bridgeport Chamber Online auction ends this weekend, along with watch parties (in lieu of a traditional banquet). BEDC is sponsoring the Sacks for Success for the Chamber scholarship and has items purchased at Ken's Appliance for the auction.
