ANNOUNCEMENTS AND SPECIAL PRESENTATIONS:

Mayoral Update - City is working to get a master park plan. Ercot has billed City \$2.2 million in costs from the winter storm. City has been having workshops on water quality and plans for improvements. City is buying a new pump for chemicals to help with consistency. New reserve tanks will be put on 21 acres recently purchased. City is to receive \$1.4 million from the American Rescue Plan.
