- 1. Project Updates
 - a. Board Information Virtual Sales Tax training information was presented.

Angie Tyson made a motion to offer Dry Creek Partnership an EDPA for the actual cost up to \$50,000 to extend the water and sewer infrastructure from the North point to the South point of their property on Highway 380 to aid in the development of a National brand food chain within 18 months.
