- Project Updates
 - Board Information New Board Members will be sworn in before our next meeting.
 - Strategic/Action Plan This will be an action item. No need for update discussion this month.
 - Sales Tax May 2022 net payment was \$ 304,150, up 15.3% over last year.
 Fiscal YTD is \$1.95M, up 22.2% over last year. YTD \$1.23M up 22.1% over last year.
 EDC's portion of net payment is \$101,383.
 - Buildings/Grounds Fence maintenance at Endeavor is complete. Ongoing maintenance at Endeavor rental property (HTP) for septic issues. Maintenance at 608 13th is required for drainage water washing out earth around the building.
 - Endeavor None.
 - o Dry Creek Retail Development None.
 - Marketing Working on social media and google marketing.

- Project Spire 2.0 Business is current on loan payments and performance agreement. They would like to give the Board a tour of the bottling facility.
 BEDC will consider having an offsite meeting there next month.
- Main Street The business we were trying to recruit to 905 Halsell is no longer interested. We will continue to try to recruit retail for multiple locations on Halsell.

- New Commercial Businesses Scooter's continues to make good progress.
- 1102 Halsell Street Conceptual drawings have been completed and prioritizing
 of projects has taken place. It is the opinion of the parks board and council that
 the downtown green space should be high priority. BEDC discussed the
 possibility of assisting with getting this project started.
