ANNOUNCEMENTS AND SPECIAL PRESENTATIONS:

- Leah Clark reported that on June 30th, a Job Fair was held in partnership with Parks and Rec, Main Street, and City. 16 businesses and 40 job seekers participated. Christmas in July is this Saturday; volunteer opportunities are available. Taste Bridgeport will be September 24th - free ticket for volunteers
- Mike Murray and Chris Heasey presented an opportunity to BEDC for funding the engineering on the 1102 Halsell Street Park Project.

STAFF AND COMMITTEE REPORTS:

- Project Updates
 - Sales Tax July income was reported to be around \$ 254,000, BEDC deposit should be about \$83,500

- Endeavor Seasonal mowing has been done at Endeavor. Honey locust tree removal, getting rid of overburden, and Parks and Recreation road work (with grant money) will begin soon. Leah Clark attended a meeting with Atmos and city officials to discuss expansion of gas lines through Bridgeport - 10 miles from station at 16th St to Runaway Bay. They are planning to start expansion in August.
- Dry Creek Retail Development Framing has started on Whataburger.
 Brookshire's is planning an expansion for August that will include more prepared meals, sushi, fresh fish, and a fresh meat market. 15,000 sf expansion to come following residential development near them.
- Marketing ThinkMents is working on social and google. EDP Best Practices working on Endeavor marketing package. Survey on the Business Park area will be needed.
- o Project Spire 2.0 No updates.
- o Main Street Buildings are available for sale and/or lease.
- o BPW/Pantera Ventures No updates.
- New Commercial Businesses Scooter's is open. American Communications has purchased a building on Hwy 101. They have a contract with county emergency communications. Nextlink is planning a broadband expansion - in ground and point to point.
