- Project Updates
 - Board Information Welcome, Mark Tate to the Board! Dates for upcoming meetings December 15, January 26, March 2, and March 30.
 Monday, November 7, Wise County Chamber is hosting an economic development forum starting at 8:30 am.
 - Strategic Plan No update.
 - Sales Tax October sales tax deposit was \$255,620 with the BEDC portion being about \$85,000 up 15.3% from last year. YTD gross deposits total \$2.5M, which is up 12.9% from last year.
 - Buildings and Grounds HTP lease has been renewed. Building could use some cleaning up around it.

- Endeavor Liberty Trailers has decided to expand into Sulphur Springs.
 Next step is having the business park surveyed. Atmos engineers are checking into adding a tap at 380 to provide natural gas into the business park.
- Dry Creek Retail Development The three remaining 380 frontage parcels are under contract.
