 - Sales Tax May Net Pmt \$341.42k, up 12.3% over last year. Fiscal YTD \$1.99m, up 2.23% over last year. YTD \$1.25m, up 1.26% over last year.
 - Project Spire 2.0 Loan payments are current.
 - Main Street Arcadia Theater is getting the facade and lobby painted. Chamber building will be getting a mural and facade update. Ice cream shop has sold. Index building is under contract. Post Oak Preservation has begun research to start the process of establishing a historic district.
