STAFF AND COMMITTEE REPORTS:

- Project Updates
 - Upcoming Events Bridgeport Chamber Shale Shoot is April 5th. Bridgeport Main Street Baile de Bridgeport is May 10th.
 Bridgeport Chamber Butterfield Stage Days and BBQ Cook-off is May 10th and 11th.
 - Sales Tax March net payment was \$173,010 down 28.3% over last year.
 Fiscal year-to-date is \$1.37m, down 4.4% over last year. Year to date is \$663.06k, down 3.3% over last year.
 - Endeavor BGE has sent a new conceptual plan based on Board feedback.

- Mr. Joshi's team is waiting on engineering to know what plans are for South entrance.
